

Summary of Club officer Responsibilities

President (elected)

Preside at all meetings of the BOARD and the club. Attend all dances and introduce guest and callers. Keep harmony and enthusiasm with the club. Be responsible to see that guests are greeted and made to feel welcome and may also appoint greeters from the general membership. Schedule callers for club dances.

Vice-Presidents (elected)

Serve as refreshment chairpersons for all regular dances. Perform all Presidents' duties upon request of absence.

Recording Secretary (elected)

Keep minutes of all meetings. Handle all correspondence as necessary and provide minutes for board meetings.

Secretary Newsletter (elected)

Gather information, prepare and deliver to club members a monthly newsletter. Prepare and provide to members Club Membership Roster.

Treasurer (elected)

Collect monies and make payments for club activities. Provide a monthly financial report to the BOARD. Collect and maintain record of member's insurance payments.

Publicity Chairperson (elected)

Responsible for advertising and other dance publicity. Organize telephone committee or other communication so all club members are notified of club news and events.

Visitation Chairpersons (appointed)

Responsible to schedule all club visitations and keep record of banners collected and retrieved and visitations from other clubs.

A Square D Representative (elected)

Responsible for attending quarterly and monthly district A Square D Meetings and reporting back to the club.

Sunshine Chairperson (appointed)

Responsible for keeping the club members advised of member's illnesses and communicating on behalf of the club.

Historian (appointed)

Responsible for maintaining club historical events and club activities.

Club Class Chairperson (appointed)

Coordinates and collects monies for beginner's workshop. Currently handled by monthly rotation
